 - ii. This Municipality is not responsible for any dispute arising in respect of ownership of the premises of the trade/industry/concern.
 - iii. All the conditions laid down in the Permission No: dt. should be strictly followed.
 - iv. Any other licence/clearance/NOC/registration/ Approval etc, required if any under the provisions of any other Rules/Act/Bylaws in force in the Union Territory of Puducherry shall be obtained.
 - v. Registration Certificate shall be obtained separately from the Department of Food Safety, Government of Puducherry, in case if the trade/industry/concern relates to **FOOD/EATABLES.**
 - vi. All pending dues to this municipality is liable to be paid by the licensee.
 - vii. The licensee shall comply with the provisions of Solid Waste Management Rules 2016, Bye-laws made thereunder and instructions issued by Oulgaret Municipality for better Solid Waste Management practices. Any violations of provisions of any Act, Rule, Bye-laws in force in Union Territory of Puducherry and any non-compliance of instructions issued by Oulgaret Municipality shall result in revoking of licence and sealing of licenced premises forthwith.
